*You are hereby notified that I have amended Approval No. A480104 issued on May 25, 2015 and amended on February 16, 2017 for a Waste Disposal Site (Landfill), as follows:*

***The following conditions are hereby revoked and replaced as follows:***

**Site Closure**

36. Once the Site reaches its approved final contours specified in Condition 38 or if the Company chooses to close the Site permanently before reaching Site capacity, the Site shall be closed and capped in accordance with Section 4 of the report that is listed as Item 24 of Schedule A of this Approval, as well as the supplier and installation quality assurance programs as outlined in Item 26 of Schedule A of this Approval.

**The following items are hereby added to Schedule "A":**

- 24. Amendment to Approved Closure Plan, Domtar Mill Residue Landfill (Big Ben), Cornwall, Ontario, BluMetric Environmental, December 18, 2017.

***The reason for this amendment to the Approval is as follows:***

*The reason for amending Condition 36 is to allow changes to the design of the final cap while providing adequate protection to the environment.*

**This Notice shall constitute part of the approval issued under Approval No. A480104 dated May 25, 2015**

*In accordance with Section 139 of the Environmental Protection Act, you may by written Notice served upon me, the Environmental Review Tribunal and in accordance with Section 47 of the Environmental Bill of Rights, 1993, S.O. 1993, c. 28 (Environmental Bill of Rights), the Environmental Commissioner, within 15 days after receipt of this Notice, require a hearing by the Tribunal. The Environmental Commissioner will place notice of your appeal on the Environmental Registry. Section 142 of the Environmental Protection Act provides that the Notice requiring the hearing shall state:*

- a. The portions of the environmental compliance approval or each term or condition in the environmental compliance approval in respect of which the hearing is required, and;
- b. The grounds on which you intend to rely at the hearing in relation to each portion appealed.

*Pursuant to subsection 139(3) of the Environmental Protection Act, a hearing may not be required with respect to any terms and conditions in this environmental compliance approval, if the terms and conditions are substantially the same as those contained in an approval that is amended or revoked by this environmental compliance approval.*

*The Notice should also include:*

1. The name of the appellant;
2. The address of the appellant;
3. The environmental compliance approval number;
4. The date of the environmental compliance approval;
5. The name of the Director, and;
6. The municipality or municipalities within which the project is to be engaged in.

*And the Notice should be signed and dated by the appellant.*
